******Important Notice of Postponement******

Transition Date Postponed

The go-live date of transition to the Single Pharmacy Benefit Manager (SPBM) to Magellan Medicaid Administration, LLC's (MMA) Pharmacy Benefit Manager (PBM) has been postponed to **October 28**, **2023**.

New Pharmacy Benefits Manager

Starting October 28, 2023, MMA will be the Single PBM for the approximately 1.7 million Beneficiaries of (6) six managed care organizations (MCOs): AmeriHealth Caritas, Aetna Better Health, Healthy Blue Louisiana, Humana Healthy Horizons, Louisiana Healthcare Connections, and United Healthcare Community Plan.

Claim Submission Information

Pharmacy claims with a date of service on or after October 28, 2023 must be processed using MMA's RxBIN, RxPCN, and Rx Group assigned numbers, which are included in the table below. Pharmacy claims with dates of service prior to October 28, 2023 must be submitted to the prior MCO PBM pharmacy claims processor.

The following claim submission fields and requirements are being **highlighted** to assist in your claim filing success during this transition. All claims must be submitted under the NCPDP Telecommunication Standard Version/Release D.O. The following fields are claim submission differences, effective **October 28, 2023**.

ID Cards

Member ID cards with the new processing information (Rx BIN, Rx PCN and Rx Group) have been issued by the MCO's ahead of the originally planned transition date. It is possible that beneficiaries will present their new ID cards to the pharmacist ahead of the transition date. Pharmacists should notify beneficiaries of the delay in transition and inform them that the claim will be processed through their current MCO PBM. Beneficiaries should produce their new ID cards on or after October 28, 2023, for their information to be updated in the beneficiary's respective pharmacy system.

Pharmacy Testing

MMA encourages pharmacies to submit test claims prior to the transition. MMA will be accepting test claims during the testing window from **August 28, 2023, through October 20, 2023**. If you would like to submit test claims, please e-mail MRxPharmacyTesting@magellanhealth.com with your contact's name, phone number, pharmacy National Provider Identifier, and Switch information to receive the testing packet.
